### **Sub-committee reports:**

#### **Jail Population Review:**

60 in jail; 13 were locked up over the weekend. EMP 14

#### **TAD report:**

There are 17 individuals in the Ashland County Jail on holds. 14 of the 17 are pending revocations.

#### **Adult Drug court report:**

15 participants; two participants will be graduating soon. Two assessments have been completed for possible placement in the program.

## **Longrun report:**

737 community service hours completed by adults; 146 hours by juveniles.

## **Children of Incarcerated Parents:**

The meeting date has changed to the second Wednesday of the month, 8AM, jury room.

The jail pamphlet has been updated and the video playing in the court house hallway has been updated and the Sesame Street video removed. There was a discussion about the homeless and how to address the issues in the community. Kim Lawton and Patrick Bourbon are working with Northlakes to provide free legal services to low income people. The purpose is to assist with small claims, restraining orders or injunctions, and limited family law.

## **New Business:**

Reba Rice from Northlakes: they are writing a grant to obtain funding for an opiate program. Medication assisted treatment, outpatient treatment, and a inpatient treatment structure. Suboxone will be used as a detoxifying agent for 2 -3 weeks.

Kelly McKnight – The caseload for the District Attorney’s office is on pace for 500 felony charges this year. There were 68 felony cases as of 2/23/2015. Last year at the same time there were 24 felony cases filed.

Abbey Kelly - Abbey provided AWARE grant information. The goal of the AWARE grant is to provide training about Mental Health First Aid for Youth to professionals and lay people in the Chequamegon Bay area. The training assists in identifying mental health issues sooner and getting help for the person sooner. There will be a needs assessment of the community.
