SPS 383.32(f) requires final discharge of domestic wastewater (which means the type of wastewater normally discharged from or similar to that discharged from plumbing fixtures, appliances and devices including, but not limited to sanitary, bath, laundry, dishwashing, garbage disposal and cleaning wastewaters) or POWTS effluent to the ground surface is **prohibited**, including by means of plumbing outfall pipes.

SPS 383.54(3) (c) requires pumping of a holding tank when the wastewater level in the tank rises to one foot (1') below the inlet pipe.

Any violation(s) of the above provisions will result in a Penalty. Any person, firm, or corporation and/or contractor found guilty of violating any provision(s) shall forfeit a sum of up to \$500.00 daily, together with the full costs of such prosecution, plus the costs of any compliance required to rectify the violation. Each day's failure to comply shall constitute a separate violation.

I (We) consent to county officials charged with administering compliance to have access to the above-described parcel at any reasonable time for the purpose of inspection. In addition, each undersigned owner(s) of the above-described property agrees to authorize the Ashland County Zoning Administration to record this affidavit of waiver.
