Ordinance No. 004-2004-51

An Ordinance Adopting An Updated Fee Schedule For Ashland County

WHEREAS, the present fee schedule administered by the Ashland County Zoning Administration Office was enacted on December 15, 1999, and

WHEREAS, at it's March 12, 2004 meeting, the Zoning and Land Committee of the Ashland County Board of Supervisors recommended that the Ashland County Board enact an ordinance adopting the new fee schedule which is annexed hereto,

NOW, THEREFORE,

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF ASHLAND,
DOES ORDAIN AS FOLLOWS:

1. The fee schedule which is annexed hereto and which is incorporated herein by reference is hereby adopted as the fee schedule for Ashland County to be followed by the Ashland County Zoning Administration Office, effective upon publication of this Ordinance.
2. When the annexed fee schedule is effective, it shall supercede and take the place of the fee schedule which is now in effect.
3. As per Section §59.14(1), Wisconsin Statutes, the County Clerk shall immediately publish this Ordinance as a Class I notice under Chapter 985 Wisconsin Statutes. The Clerk shall procure and distribute copies of this Ordinance to the several Town Clerks, who shall file it in their respective offices.
