

**AN ORDINANCE AMENDING SECTION 4.61 OF THE
ASHLAND COUNTY SHORELAND AMENDATORY ORDINANCE**

WHEREAS, Ashland County's Shoreland Amendatory Ordinance, which was originally adopted January 19, 1971, was amended on September 10, 1985, and on June 4, 1991, and

WHEREAS, in January, 1994, the State of Wisconsin Department of Natural Resources forwarded to Ashland County revised and updated Wetland Inventory Maps for Ashland County, and

WHEREAS, such revised Wetland Inventory Maps represent wetland boundaries and base map photography which is more current so adoption of the updated Wetland Inventory Maps for Ashland County may reduce map amendment requests and associated workload, and because the maps are of higher quality and have a better key on them, they are more accurate and easier to use, and

WHEREAS, on April 2, 1996, after proper public notice, the Zoning, Mining and Land Committee of the Ashland County Board of Supervisors held a public hearing on a proposed amendment to Section 4.61 of the Ashland County Shoreland Amendatory Ordinance, a copy of which is attached hereto and is incorporated herein by reference, and

WHEREAS, on November 14, 1996, at its regular monthly meeting, the Zoning, Mining and Land Committee of the Ashland County Board of Supervisors approved such amendment to Section 4.61 of the Ashland County Shoreland Amendatory Ordinance,

NOW, THEREFORE, the County Board of Supervisors of Ashland County does ordain as follows:

That Section 4.61 of the Shoreland Amendatory Ordinance of Ashland County, Wisconsin, is hereby amended to provide as follows:

"4.61 Designation.

This district shall include all shorelands within the jurisdiction of this ordinance which are wetlands of five acres or more on the Wisconsin Inventory Maps revised on May 3, 1990, May 11, 1990, May 18, 1990, May 10, 1991, May 13, 1991, May 14, 1991, May 17, 1991 and September 28, 1995 (09-28-95) that are hereby adopted and made a part of this ordinance and are on file in the office of the zoning administrator for Ashland County. That portion of a wetland located in the shoreland area that extends across the corporate limits of the municipality, across the County boundary or across the shoreland limits in the unincorporated area of the County, shall be included in this district if the wetland would otherwise be regulated if it were wholly within the shoreland area under County jurisdiction."

The County Clerk of Ashland County shall immediately publish this ordinance as a Class 1 notice under Chapter 985, Wisconsin Statutes, and shall distribute a copy of this ordinance to the several town clerks, who shall file the same in their respective offices.
